My dog may be videotaped, photographed and recorded when on Doggie Central and/or The Dog's Garage Ltd. premises and Doggie Central Ltd. or The Dog's Garage Ltd. shall be the exclusive owner to the results and proceeds of such taping, photography and recordings with the rights, throughout the world, of unlimited use, and to copyright, to use and license in any manner.
